- Wayne Z. talked about his type set including a gold coin page- completed in just six years!
- Bill S. likes Buffalo nickels. Hs is working on a set with full horns— on a budget.
- ◆ Charley B. discussed the new cents. 2008 had the last Lincoln Memorial coins. 2009 had the Lincoln from early childhood to the White House in four different coins— all a one year set. 2010 has the shield on the reverse. When you think about it, these are 1 year designs, so they may be more collectable and harder to get or more valuable in the future.
- Joe M. has collected currency for about 15 years. He mentioned a few choice finds. He recently bought 2 star notes at Santa Clara for \$20, and checked with a dealer, who said they were worth \$200 each. He discussed some other great finds— they are still out there!

- Richard W. picked one of the four Barber dimes he needs at our show. At the Santa Clara show all the other 3 were there in the 'condition' needed, but were clearly overgraded. Even a PCGS coin looked overgraded. He did NOT buy it just to have it.
- Willie is into Indian cents and a US Type set- all in holey condition. He thanked the various club members for their donations to his collection.
- Dan M. is interested in Love Tokens, and has started collecting them.
- Jim C. was in Carson City, where he found a Carson City Savings Bank note, and others from the S.F.Savings Bank, etc. These were notes for people who brought in gold and silver bullion in the old days. Nice little pieces of history.
- ◆ Dan C. bought an Indian Cent Dansco Album, which lists an 1866 type 2, a re-punched mint mark, that is not listed on a Whitman Album.
- Glenn C. is working on a set of Silver Eagles.
   Proofs now go for up to \$70 or more, so he fills it in with other silver dollar type coins.
- ◆ Merle was one of 3 members present who have an 1876 20 cent piece. Hope I got the date right, is was a very low mintage and his was a very high grade.





#### ANCIENT COIN NEWS

"The Ancient Coin Collectors Guild is a non-profit organization committed to promoting the free and independent collecting of coins from antiquity. The goal of this guild is to foster an environment in which the general public can confidently and legally acquire and hold any numismatic item of historical interest regardless of date or place of origin. ACCG strives to achieve its goals through education, political action, and consumer protection.

The U.S. State Department had announced a date of May 6-7 for Cultural Property Advisory Committee hearings on the request for renewal of the Memorandum of Understanding with Italy. In practical terms, the U.S. government is about to decide whether antiquities and other forms of cultural property that Italy claims as its heritage ought to be restricted from entry into the U.S. unless accompanies by Italian export permits. There is already such an agreement in place, but ancient coins have been exempted twice before in these renewal requests that cover a 5-year window. We have very good reason to believe that Italy and members of the archeological community will this time seek to add coins to the list of restricted items.

Why oppose these import restrictions? Because Roman coins are at the very core of the cultural experience that we all treasure. They have circulated all over the known world in antiquity and since through trade and collector markets. It is impossible to distinguish a Roman coin found in Britain, for example, from exactly the same type, mint, etc found in Italy. Requiring an export permit from Italy for a coin found and legally exported from Britain would not only be impractical, it would not have any legal foundation."

The above info is copied directly from the ACCG site for accuracy. One interesting other fact is the entire European Union has an express agreement NOT to restrict the legal trade or sale of any country's coins. So all of Europe would still be collecting while excluding only the United States if this passes.

I am a member of the ACCG and I encourage all of you to join. Through the ACCG I was able to send a personal fax expressing my opposition to this illogical government control. Over 1800 of us sent faxes to our State Department to try to persuade them not to pass this biased and unfair Memorandum of Understanding. And it is possibly just the beginning if other countries try to jump on the bandwagon and try to ban collecting in the U.S. You can just sit there and watch it happen. Or you can join and make a difference for our hobby.
